Our digital transformation proposal recommended a cloud-centric, modern desktop approach using Microsoft 365. This would entail migrating to Exchange and moving files to SharePoint and Teams. We also introduced the firm to one of our key partners, LEAP, a cloud-based practice management and accounting software provider specifically designed for law firms, to modernise their legacy apps.

We brought in our network specialist to update the network infrastructure and using our preferred partnership with Dell, we were able to source discounted hardware, laptops and desktops to replace kit where necessary and complete the hardware refresh. These devices were preconfigured using AutoPilot and ready to use, and any remaining kit was configured using Microsoft Intune to be compatible with the new applications to minimise down time.

The cloud migration project took just one month to complete, including the move of over 1.2 terabytes of data into SharePoint.
